Full Text:

1. In Graphic abstract, Figure 4 and Table 2, the labels for (+)-isoborneol and (–)-isoborneol should be switched.
2. 1. In Figure 1, the labels for *d*-isoborneol and *l*-isoborneol should be switched.
3. On Page 349, in Figure 2, the label for (+)-isoborneol should be (–)-isoborneol.
4. On Page 350, in Section 3.1, the first line of the second paragraph, “(+)-Isoborneol, synthesized as previously described” should be “(–)-Isoborneol, synthesized as previously described”.
5. On Page 351, in the legend for Figure 4, the order of (+)-isoborneol, (–)-isoborneol should be switched.
